Approved minutes from last meeting on 4/5/2023. Motion by Larry D'Angelo, second by Paul Richards, unanimously approved.

## **Financial Report**

April 2023, cash receipts totaled \$2,755, all from memberships and donations. Last year April memberships and donations were \$4,015. During the month we spent \$200 for the pancake breakfast and \$17 on credit card fees. We also received a refund of \$377 from White Lake Township for the Winter Carnival fireworks permit. As a result, the cash balance has grown from \$45,916 to \$48,831. The cash balance is only \$110 less than it was one year ago despite the lower membership and donation receipts in 2023 which is likely due to **not having sent out** the hard copy newsletter yet this year. The newsletter has been sent to the printer and a proof copy is expected Tuesday 4/25/2023 and it should be mailed by May1st.

April 2023 Year to date cash receipts have totaled \$3,222 of which \$3,220 is for memberships and donations. In 2022 April year to date memberships and donations were \$6,058. The reduced level of memberships and donations is due to not having the winter carnival and not having the newsletter mailed yet this year. The lower 2023 cash receipts is fully offset by lower 2023 expenses due to not having the winter carnival. As mentioned above the current cash balance is just \$110 less than it was at the end of April 2022.

Motion to approve Financial Report by Larry D'Angelo, second by John Millington, unanimously approved Financial Report.

## Membership

All files have been transferred to Barb Richards. Joe and Barb will collaborate to discuss block captain transition. Joe will spearhead the next steps with the block captains. 42 people have paid. Flags are in for 2023. Discussion to make 2024 flags 2 sided.

### Pancake Breakfast

Discussion to raise the price of breakfast. Cost is \$6.95. Last year's price for adults was \$10.00 and kids \$5.00. It was agreed to keep the price the same for 2023. The objective of the Pancake Breakfast is to increase membership and sell merchandise. Discussion to add Venmo as a form of payment. Also, discussion for background music this will be further researched.

Motion to keep the cost of the breakfast the same by Larry D'Angelo, second by John Millington, unanimously approved to keep the price of the Pancake Breakfast the same as 2022 prices.

### Fireworks & Boat Parade

The POG for the Fireworks is still being created. The discussion was to keep putting pressure on ACE for a better 25-minute show. Looking for a new person for Boat Parade and a new theme.

#### Merchandise

Finalizing designs and colors for 2023. When complete designs will be sent so they can be launched on our website for presales. The merchandise will be ready for the Pancake Breakfast. Additionally, we need to promote last year's merchandise. A lot of discussion on this but it was decided Elizabeth has carte blanche to get rid of the inventory in the best way she sees fit.
